ISSUE 2A - SERVICES EXPANSION Fee: Shall the City of Broomfield Taxes be INCREASED \$1,620,000 Annually in the First Full Fiscal Year by Imposing a New SERVICES EXPANSION Fee Excise Tax of Not More Than One Dollar (\$1.00) for Each New Square Foot of Total Floor Area for All New Residential Construction within the City for the Purpose of Providing Funds That May Be Expended for the Construction or Improvement of Educational or Municipal Facilities or for any Other Lawful Purpose; And Shall All REVENUES THEREFROM and any Earnings from the Investment of the REVENUES be Collected and Spent for Such Purpose Without Limitation or Condition, and Without Limiting the Collection or Spending of any Other REVENUES or Funds by the City Under Section 20 of Article X of the Colorado Constitution or any other Law, Such Amounts to Constitute Voter Approved Revenue and Spending Charges?
