CANVASS BOARD - SCOPE OF DUTIES

Title 1, C.R.S.

1-7.5-208 Certificate of mail ballots cast - survey or returns.

- (1) Repealed
- (2) Upon the survey of the returns of the political subdivision by the board of canvassers formed pursuant to section 1-10-101 or 1-10-201, the board shall include in its abstract of votes the votes cast in the voter service and polling center and counted at the counting place in the manner provided for abstracting votes cast and counted in accordance with article 10 of this title.
- (3) (a) (I) The returns certified by the judges and the abstract of votes cast certified by the canvass board shall, except as provided in subparagraph (II) of this paragraph (a), indicate the number of votes cast in each precinct for each candidate and for and against each ballot issue and ballot question and the number of ballots rejected, except as otherwise provided in paragraph (b) of this subsection (3).
 - (II) For primary and coordinated elections, the judges and canvass board shall either:
 - (A) Certify the votes cast in each precinct pursuant to subparagraph (I) of this paragraph (a); or
 - (B) Certify on the returns and the abstract of votes cast the number of votes cast on each ballot style for each candidate and for and against each ballot issue and ballot question and the number of ballots rejected.
- (b) If the total number of votes cast and counted in any precinct is less than ten, the returns for all such precincts in the political subdivision shall be reported together.

1-10-101.5 Duties of the canvass board.

- (1) The canvass board shall:
 - (a) Reconcile the ballots cast in an election to confirm that the number of ballots counted in that election does not exceed the number of ballots cast in that election;
 - (b) Reconcile the ballots cast in each precinct in the county to confirm that the number of ballots cast does not exceed the number of registered electors in the precinct; and
 - (c) Certify the abstract of votes cast in any election and transmit the certification to the secretary of state. A majority of canvass board members' signatures shall be sufficient to certify the abstract of votes cast in any election. When unable to certify the abstract of votes by the majority of the board for any reason, the canvass board shall transmit the noncertified abstract of votes to the secretary of state along with a written report detailing the reason for noncertification.

Colorado Secretary of State Election Rules

10.3 Duties of the Canvass Board

10.3.3 The canvass board may not perform duties typically reserved for election judges while canvassing the results, including:

- (a) Determining voter intent;
- (b) Evaluating voter eligibility, including reviewing signatures that have been accepted or rejected; and
- (c) Requesting new logs or reports that were not created to conduct the election.

10.5 Procedures for Canvass

10.5.1 The designated election official must provide the following information to the canvass board:

- (a) The name of each candidate, office, and votes received;
- (b) The number or letter of each ballot issue or question and votes received;
- (c) The total number of ballots cast;
- (d) The number of provisional ballots cast, including totals for:
 - (1) Ballots accepted by each code; and
 - (2) Ballots rejected by each code.
- (e) The number of mail ballots cast, including totals for:
 - (1) Ballots accepted; and
 - (2) Ballots rejected by each code.
- (f) The number of in-person ballots counted;
- (g) The number of damaged and spoiled ballots.
- (h) If applicable, the number of ballots cast in each party's primary election, including totals for:
 - (1) Ballots accepted in each party's primary election by affiliated and unaffiliated voters; and
 - (2) Ballots rejected by each code.

10.6 Official Abstract and Reporting to the Secretary of State

10.6.1 The official county abstract must include, by precinct or ballot style, where applicable:

- (a) The total number of active registered electors on election day;
- (b) The total number of registered electors (active and inactive) on election day;
- (c) The statement of votes counted by race and ballot question or issue; and
- (d) The total number of ballots cast in the election.

10.6.2 A county must submit the state portion of the abstract and the ENR upload required by Rule 11.9.6 to the Secretary of State in the format approved by the Secretary of State. The state portion of the abstract must include:

- (a) The summary of votes cast for each state race and each ballot question or issue; and
- (b) The total number of ballots counted in the election.
