RESOLUTION NO. 2026-2

A Resolution Adopting the Environmental Health Fee Schedule

Now, therefore, be it resolved by the Board of Health of the City and County of Broomfield, Colorado:

Section 1.

The Broomfield Board of Health hereby adopts the Environmental Health Fee as set forth in Exhibit A (attached). Any current fees not set forth in Exhibit A remain in effect.

Section 2.

The fees for 2026 are effective as of the date of approval until December 31, 2026. The fees for 2027 will be effective January 1, 2027 until December 31, 2027. The fees for 2028 will be effective January 1, 2028 until new fees are adopted.

Section 3.

This resolution is effective on the date of approval by the Broomfield Board of Health.

**To qualify for a No-Fee Permit, you must meet one of the following criteria from §25-4-1607 (9)(a): (I) Public or nonpublic school for students in kindergarten through twelfth grade or any portion thereof; (II) Penal institution; (III) Nonprofit organization that provides food solely to people who are food insecure, including, but not limited to, a soup kitchen, food pantry, or home delivery service; and (IV) Local government entity or nonprofit organization that donates, prepares, or sells food at a special event, including, but not limited to, a school sporting event, firefighters' picnic, or church supper, that takes place in the county in which the local government entity or nonprofit organization resides or is principally located.
